The **Pricing** component add-in provides the connectivity to a retailer's environment or other external entity along with the associated business rules for pricing a consumer's basket, and enables couponing, discounting and loyalty point accumulation and instant gratification.



The **Tendering** component add-in provides connectivity to a retailer's environment or other external entity along with the associated business rules for authorizing an electronic tender for payment of a consumer's basket, and enables loyalty or gift card redemption transactions in a secure PCI-Compliant manner.
